Responsible Steel Supply

Orrcon Steel Manufacturing has attained Sustainable Steel Australia (**SSA**) **Level 1 Certification** as a General Manufacturer for the Salisbury (Qld) and Unanderra (NSW) structural pipe and tube manufacturing sites.

The SSA Program is designed to identify sustainable steel suppliers by assessing the environmental and social impact of their manufacturing and processing operations. In achieving **Level 1 - SSA certification** Orrcon Steel Manufacturing is demonstrating a commitment to continuous improvement in governance and OHS&E management.

The steel coil used is sourced from BlueScope's Port Kembla Steelworks a <u>ResponsibleSteel™</u> certified site and SSA Verified Steel Supplier.

Orrcon Steel Manufacturing has undertaken *Life Cycle Analysis* of its manufactured product range and developed an **Environmental Product Declaration** (**EPD**) that covers our range of **Pipe and Tube Products** from all manufacturing sites.

This **EPD** was developed in line with Product Category Rules 2019:14 Construction products, version 1.3.4, it is independently verified, registered with EPD Australasia, and is compliant to ISO 14025, and EN 15804+A2:2019/AC:2021.

Orrcon Steel Manufacturing's SSA Certification and EPD credentials are both recognised as Responsible Product initiatives under the Green Building Council of Australia's (GBCA) - Responsible Products Framework (RPF). When combined with BlueScope Steel's ResponsibleSteel™ certification and SSA Verified Supplier status our Pipe and Tube products can achieve 'Best Practice' status.

- Certification to SSA level 1 meets the requirements to gain a responsible product value (RPV)
 of 4 under the 'Responsible' category in the Green Star Buildings rating tool.
- EPDs include a verified embodied carbon footprint and assist in 5 RPV credits in Green Star Buildings for the following:

 Sourcing steel from BlueScope Steel, a Verified SSA Supplier and ResponsibleSteel™ certified Site, provides 10 RPV.

A combination of ResponsibleSteel, Product-Specific EPD and SSA Level 1 under GBCA's RPV methodology results in an RPV equivalent to a Best Practice product (≥15).
