Producer's description

The production and physical characteristics of Orrfire[®], SMARTCOTE[®], extra-light pre-painted sprinkler pipe are summarised as follows:

- The pipe is produced as ERW tube from Hot Rolled steel strip.
- Steel is processed in accordance with AS1074.
- Steel properties conform to AS/NZS 1163 Steel Grade 350L0.

Pipes are produced in wall thickness that meet or exceed those specified in AS 4118.2.1 – 1995 providing suitability for use in AS 2118 – conforming sprinkler systems.

All listed sizes are suitable for use with roll-grooved type couplings and fittings of suitable diameter and groove profile. Additionally they are suitable for joining by shouldered-end coupling.

Technical specification

The following details are a representative extract of the technical specification for the Orrfire[®], SMARTCOTE[®], extra-light pre-painted sprinkler pipe and may be subject to change. Complete and current details should be determined from the designated producer's technical manual/data sheets.

1. The above mass values have been calculated based on a steel density of 7850 kg / m³ and assume a pipe of the exact dimensions listed above.

2. Wall thickness; the figures are "nominal" unless otherwise noted as minimum (min).

General:

Orrfire[®], SMARTCOTE[®], extra-light pre-painted sprinkler pipe is manufactured by using an electric resistance welding method in accordance with the requirements of SSL Appraisal Specification FAS-119: Version 4.0, Light ERW Steel Pipe, to AS 4118 Part 2.1, & Draft Australian Standard DR02094CP-PDR (20/02/02), for Fire Protection Systems'.

Leak-tightness:

The weld zone is tested in-line using an Eddy Current Flaw Detection System. Testing is carried out in accordance with AS 1074 section 2.8 (b) and Appendix B.

Pre-painted external coating:

Pre-painted coating is a water-based semi-gloss polymer coating applied to the external surface of the pipe. The average "dry film thickness" is 10 to 15 microns. The coating is available in red (red gum) or black.
